- 1 bill for the transport and for the supply of gas and Electricity (if your network provider agrees to this arrangement)

ENGIE will as a standard apply the 0-rate for NATO employees. If the 0-rate is applied, NATO employees are exempt from VAT and REB under the Netherlands tax jurisdiction.

- This contract is for an undetermined period of time. The contract necessarily terminates on termination of your stationing in the Netherlands. In the event of a transferral, no period of notice is applicable.
- This contract is person-related. ENGIE will continue supplying to your new address if you are transferred in the Netherlands. ENGIE will be responsible for passing on your transfer data to the network provider(s). The same terms will continue to apply at the new address.
- 3. Administration expenses are charged on payments by giro collection form.
- 4. By signing this contract, you transfer Programme Responsibility to ENGIE. This means that ENGIE assumes responsibility for supplying the right volume of electricity to the connection.
- 5. ENGIE respects effective energy contracts with other energy suppliers. Before effectuating a switch of supplier, ENGIE will verify through the nationwide protocol for contract verification (Contract Controle Protocol) whether you have an effective contract with another supplier for the supply of gas and/or electricity. This safeguards you from having two energy contracts. If you have an effective contract, ENGIE undertakes to terminate this contract by the first due date. Thereafter, ENGIE will switch the connection by the first possible date after termination of the first contract and complete the switching procedure. As other suppliers may not be fully equipped to comply with the rules of the Contract Controle Protocol, we request you to inform us anyway of another contract you may have with another supplier of energy.
- 6. To this agreement the variable tariffs and general conditions for the supply of gas and/or Electricity for household consumers apply. The tariffs and conditions may be requested free of charge from ENGIE. The tariffs and conditions are also available at www.engie-energie.nl
- 7. Your network provider is responsible for the reading of the meters. ENGIE will notify your network provider of your switching and pass on the meter readings as stated by NATO. If the meter readings deviate too much from the meter readings as calculated by the network provider, the network provider will base its charges for completion of your switch to ENGIE on its own meter readings.
- 8. If a complaint about the origination or the performance of this contract is not settled to your satisfaction, you may submit the dispute to an independent arbitration committee (www.geschillencommissie.nl) or to a competent court in the Netherlands.
